NOTICE

DR. GAGAN S. CHADHA ACADEMIC SCHOLARSHIP FOR THE YEAR 2014-15

1. Objective:-

To provide financial assistant to needy students belonging to low income families to meet out part of their day-to-day expenses while pursuing higher studies in medical stream.

2. Number of Scholarships:-

Three (3) scholarship will be awarded every year, and each scholarship shall be for a period of 1 year. One scholarship each will be awarded to students passing 1st, 2nd and 3rd (Part-I) professionals MBBS exam, respectively.

3. Amount of Scholarship:-

The total sum of each scholarship will be Rs. 10,000/- and it will be disbursed at 3 monthly intervals in 4 installments.

4. Eligibility:-

- (i) Bonafide MBBS students of UCMS (from both General and Reserve categories) are eligible to apply who have passed the 1st Prof. Annual Examination, 11nd Prof. Annual Examination and 111rd Prof. (Part-I) Annual Examination in 1st attempt of the current academic session. ⁽²⁰¹⁴⁻¹⁵⁾ Therefore, students of 3rd, 6th, and 8th semester shall be eligible to apply.
- (ii) Applying students should have obtained at least 55% marks in the Annual Examination in 1st Attempt. Percentage of marks obtained in qualifying examination shall be calculated on total aggregate marks of all subjects.
- (iii) Income of the parents/legal guardians of the student from all sources during the previous financial year should not exceed Rs. 6,00,000/- (Six lacs only) per annum. For documenting parents/guardians income, latest salary slips in the case of parent/guardian in Govt. service and an affidavit from the 1st Class Magistrate in case where parents/guardians are not in Govt. employment. Form 16/16A's & Income Tax Returns of the previous years are also required, as the case may be.
- (iv) The student should not be in receipt of any other scholarship or financial assistance under any scheme.
- (v) The student applying for Scholarships should be citizens of India.
- (vi) Only one child of the same parents/guardians will be entitled to receive scholarships. This restriction will apply to girls also.
- (vii) Application should be submitted in the prescribed format only.
