

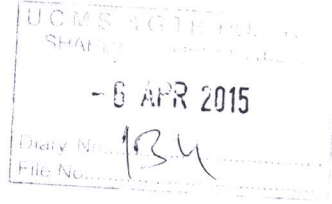

Subject: Recognition/Approval of University College of Medical Sciences & GTB Hospital, Delhi for award of MBBS degree granted by Delhi University against the increased intake i.e. from 100 to 150 u/s 11(2) of the IMC Act, 1956 – regarding.

Sir,

I am directed to inform you that an assessment to verify the compliance as submitted by the college authorities on rectification of the deficiencies pointed out in the assessment report (11th & 12th December, 2013) with regard to recognition/approval of the University College of Medical Sciences & GTB Hospital, Delhi for award of MBBS degree granted by Delhi University, Delhi against increased intake i.e. from 100 to 150 u/s 11(2) of the IMC Act, 1956 was carried out by the Council Assessors on 4th & 5th April, 2014. The compliance verification assessment report (4th & 5th April, 2014) alongwith the assessment report (11th & 12th December, 2013) was considered by the Executive Committee at its meeting held on 09.05.2014. The following recommendations of the Executive Committee was approved by the General Body of the Council at its meeting held on 26th & 27th March, 2015:

"The Executive Committee of the Council considered the compliance verification assessment report (04th & 05th April, 2014) with regard to recognition/approval of University College of Medical Sciences & GTB Hospital, Delhi for the award of MBBS degree granted by Delhi University and decided to recommend to the Central Govt. to grant recognition/approval for the award of MBBS degree against increased intake i.e. from 100 to 150.

The Executive Committee further decided that the attention of the institute be drawn to Sections 8(3)(2), 8(3)(3) & 8(3)(4) of the Establishment of Medical Colleges Regulations (Amendment), 2010 (Part II) dated 16th April 2010 and act accordingly at appropriate time, which reads as under:-

8 (3) ...

(2) The recognition so granted to an Undergraduate Course for award of MBBS degree shall be for a maximum period of 5 years, upon which it shall have to be renewed.

(3) The procedure for 'Renewal' of recognition shall be same as applicable for the award of recognition.

(4) Failure to seek timely renewal of recognition as required in sub-clause (a) supra shall invariably result in stoppage of admissions to the concerned Undergraduate Course of MBBS at the said institute."

In view of above, you are, therefore, requested to issue necessary notification at the earliest recognizing University College of Medical Sciences & GTB Hospital, Delhi for award of MBBS degree when granted by Delhi University, Delhi against increased intake i.e. from 100 to 150.
