It is stated that the assessment report (April, 2013) on the standard of examination and other teaching facilities available at University College of Medical Sciences & GTB Hospital, Delhi for purpose of Recognition of MS(ENT) qualification against increased intake from 02(Two) to 04(Four) seat(s) granted by University of Delhi, Delhi was considered by the Board of Covernors at its meeting held on 22.08.2013 and it was decided as under:-
