Sub: University of Delhi, Delhi - Recognition of MS(General Surgery) qualification against increased intake from 08(Eight) to 16(Sixteen) seat(s) in respect of students being trained at University College of Medical Sciences & GTB Hospital, Delhi.

Sir,

It is stated that the assessment report (April, 2013) on the standard of examination and other teaching facilities available at University College of Medical Sciences & GTB Hospital, Delhi for purpose of Recognition of MS(General Surgery) qualification against increased intake from 08(Eight) to 16(Sixteen) seat(s) granted by University of Delhi, Delhi was considered by the Board of Governors at its meeting held on 24.07.2013 and it was decided as under:-

"The Board of Governors considered the assessment report (April, 2013) and noted that MS(General Surgery) qualification is already recognized with 08(Eight) seat(s) and decided to recommend that MS(General Surgery) qualification against increased intake from 08(Eight) to 16(Sixteen) seat(s) granted by University of Delhi, Delhi in respect of students being trained at University College of Medical Sciences & GTB Hospital, Delhi be recognized and included in the 1st Schedule to the I.M.C. Act, 1956 with the number of admissions to 16(Sixteen) student(s) per year."

The Board of Governors further decided that the attention of the institute be drawn to Clauses 6.4 and 6.6 of the Postgraduate Medical Education (Amendment) Regulations, 2000, Part-II, dated 21st July, 2009 and act accordingly at appropriate time, which reads as under:-

- 6.4 The recognition so granted to a Post Graduate Course shall be for a maximum period of 5 years, upon which it shall have to be renewed.
- 6.6 Failure to seek timely renewal of recognition as required in sub-clause-4 shall invariably result in stoppage of admissions to the concerned Post Graduate Course.
