**Subject: Gathering / Protest / Demonstration etc. in the College and Hospital Complex - reg.**

UCMS-GTBH Complex, being a medical college, always strives to maintain highest standards of medical education and patient care. It is, therefore, felt that no stakeholder should indulge in any protest / demonstration / agitation etc. Such activities disrupt teaching learning activities and adversely affect patient care.

In view of the above, it has been decided that no gathering / protest / demonstration / sloganeering / dharna etc. will be organized without prior permission from the office of the Proctor.

Organizers of demonstration / protest etc. are required to provide the following information to the office of the Proctor at least three working days in advance to obtain the permission:

- (1) Name and Designation of the Organizer
- (2) College / Institution / Department
- (3) Mobile Number
- (4) E-mail ID
- (5) Course Name, if any
- (6) Program Details:
  - a) Nature of Program:  
(Protest, Public Speech, Dharna, GBM, Rally etc.)
  - b) Duration of the Program
  - c) Use of Logistics
  - d) List of Speakers
  - e) Expected No. of participants
- (7) No Objection / Permission / Intimation from the local Police Station

Any permission will be subject to such terms and conditions, as deemed fit by the Proctorial Board, and the Organizer(s) will abide by the terms and conditions of the permission.

No protest / demonstration / dharna etc. is allowed inside the buildings, corridors, foyers, porches and minimum 100 meters distance from entrances of buildings, lecture theatres, classrooms, library, wards, laboratories, offices etc. Use of loudspeakers, sound amplifiers, musical/sound instruments etc. is prohibited in the College-Hospital Complex.

The above conditions should be adhered to in letter and spirit. All the stakeholders are expected to follow them for smooth functioning of the College-Hospital Complex in providing the patient care / hospital laboratory services.

The above conditions are as per the norms prescribed by Proctor, University of Delhi.
